- All information provided in the application form will be considered when applying for the BSBI scholarship.
- The scholarship amount is awarded at BSBI's discretion and constitutes a reduction in tuition fees payable to BSBI.
- All the remaining fees must be paid according to T&C stipulated in the Programme Application Form Section 3, Programme Fees.
- If you intend to postpone your place until the following intake, you will needs to pay the remaining tuition fee. You will be permitted to do so only at the discretion of BSBI.
- 6. The scholarship is not transferable to another student.
- 7. In the event that a student does not attend a programme through serious unforeseen circumstances (death, accident, or serious illness)a specific committee will examine each case on an individual basis. Attendance is compulsory. An attendance rate of less than 90% will lead to scholarship withdrawal.
